Works in progress

Our Relationships with Animals (w/Rob Streiffer)

- Book project that develops a relationalist approach in animal ethics
- Makes substantial contributions in both normative ethics and in animal ethics
- Continues a research program that Streiffer and I have been developing over the course of three co-authored papers thus far (all of which have been or soon will be published in top journals)

‘What is Activism?’ (w/Richard Rowland)

- Develops a new theory about the nature and value of activism

‘Moral Occasionalism’ (w/Jacob Sparks)

- An elaboration and defense of an occasionalist view that Sparks and I have both independently been moving towards
- To be presented in November 2020 for UCSD MAPPS

‘Roadkill and the Moral Dimensions of Veganism as a Social Movement’

- Invited chapter in an edited volume on ‘the new omnivorism’ edited by Cheryl Abbate and Christopher Bobier
- Argues that eating roadkill is almost always wrong; to be paired against a defense of eating roadkill by Donald Brucker

‘Normative Domains’

- Corrects and improves upon the normative domain pluralism that I outlined in my 2019 OSME paper

‘Moral Fixed Points, Wittgenstein-style’

- Develops a Wittgensteinian version of the fixed-points theory suggested by Cuneo and Shafer-Landau. Committed to a Routledge volume edited by Jonathan Beale and Richard Rowland
